# 1.1 For All REJOYN® Users

## REJOYN® Does Not Replace Your Healthcare professional's Medical Advice

REJOYN® is a digital therapeutic intended for the treatment of major depressive disorder (MDD) in adults. It is intended to be used alongside standard of care and supported by a healthcare professional. REJOYN® provides neurobehavioral treatment composed of three parts: cognitive emotional training, cognitive behavioral therapy-based psychotherapy lessons, and personalized messaging.

REJOYN® is a UKCA-marked medical device and has been designed and manufactured to comply with the relevant Essential Requirements set out in the UK Medical Devices Regulations.

## 2. Changes to the Terms of Use and to REJOYN®

Otsuka reserves the right, in its sole and absolute discretion, to change these Terms of Use at any time for any reason. Should Otsuka make any changes to these Terms of Use, we will post the revised Terms of Use to REJOYN®, and the changes will be effective upon such posting. Otsuka encourages you to periodically review the Terms of Use. If you do not agree with any updates to these Terms of Use, do not continue to use REJOYN®. Continued use of REJOYN® after the effective date of a change to these Terms of Use constitutes acceptance of the updated version of the Terms of Use.

## 3. Acceptable Use and Restrictions on Use

REJOYN® is available only to persons above the age of 18, located in the United Kingdom and for use in accordance with the Intended Use. If you do not meet these requirements, you may not use REJOYN®.

You agree only to use REJOYN® for the purposes for which they have been designed. You will comply with these Terms and all applicable laws, rules, and regulations and will not encourage or promote any activity that violates these Terms.

## **Additional Restrictions**

You agree that you will not:

- use REJOYN® for any unlawful purpose or to promote illegal activities;

## 6. User Information

You own your User Information.
